**The Prix d'Excellence** is an annual award that aims to recognize innovative French-Swedish companies for their outstanding performances on the French market.

**Cirkus Cirkör** is a Swedish contemporary circus company, renowned for its enormous creativity, that pushes the limits of the impossible. Their breathtaking and innovating performances push the physical limits and create transboundary art pieces. It all started when Tilde Björfors and some artists went to Paris and fell in love with the possibilities that the contemporary circus offered. They decided to stop dreaming big and living small and instead give their all to live out their dreams. The name Cirkör is a play on the French words 'Cirque' and 'Coeur', circus and heart, and the company has played an important role behind today's recognition of contemporary circus as an art form in Sweden.

Celebrated on the 13th of December, the longest night according to the old Julian calendar, **Saint Lucie's Day** is a religious event coinciding with the return of light after the Winter Solstice. Since 1927, the Swedes have adopted and made a tradition of Saint Lucie as we know it today, with a young lady dressed in a simple white dress, wearing a crown of candles. She leads a procession of followers, also dressed in simple white dresses and sings the light in the winter darkness. The choir of the Swedish Church in Paris, under the direction of Björn Åkerhage, will give an exclusive Lucia experience during the evening.

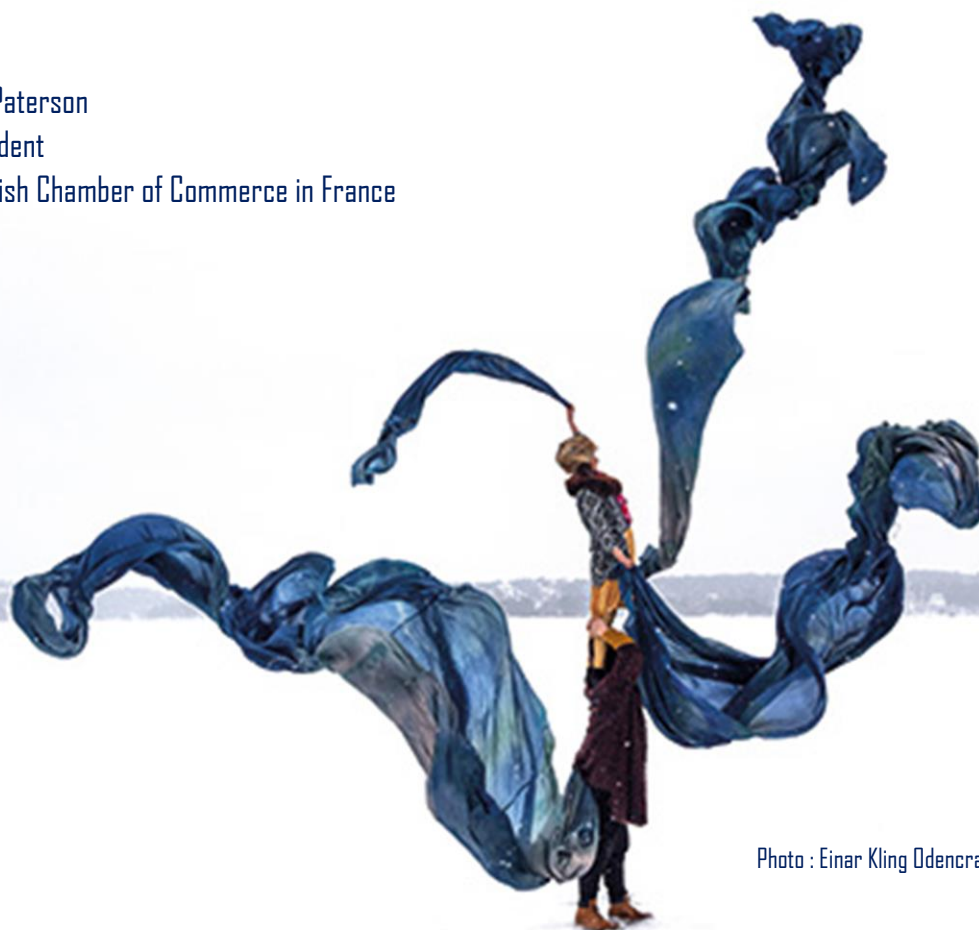
